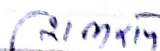
NOTES :-

- There will be only one head of fee i.e., school fee (Means Tuition Fee only).

2. The 'School Fee' is the Tuition Fee which is charged for course of study and internal examination only. The mode of teaching may be physical/online/hybrid as the case may be in accordance to the circumstances. A certificate for payment of 'Tuition Fee' will be provided to parents for the amount paid towards 'School Fee'.
3. After school hours and outsourced activity of any nature will be separately chargeable.
4. Fee for the entire academic year is chargeable irrespective of date of admission or leaving the school.
5. A student will be considered as continuing in next session only on the payment of 1st installment of the fee by 15th April of the academic session.
6. Fee shall be payable in four installments by 15th April, 15th July, 15th October, 15th January of the academic session and monthly payment may be permitted on a request by the parent in writing.
7. A late payment charge @ Rs. 50/- per day (including Sunday/Holiday/Vacation) will be levied on payment of fee after dates mention here in.
8. Non-payment of Installment by the last day of the month (April, July, October, January) will make the student entail for de-enrolment from the rolls of the School without any further notice.
9. In case if a cheque is bounced, the parent will be liable to pay Rs. 500.
10. The fee is considered as deposited on the date when the fee is credited in our account.
